

# **AN ORDINANCE REQUIRING THE SUBMISSION OF THE LIST OF JOB VACANCIES AND PLACEMENT OF ALL BUSINESS ESTABLISHMENT IN THE CITY OF GENERAL SANTOS TO THE PUBLIC EMPLOYMENT SERVICE OFFICE GENSAN.**

**WHEREAS**, Section 9, Article II of the 1987 Philippine Constitution provides that the State shall promote a just and dynamic social order that will ensure the prosperity of the nation and free the people from poverty through policies that provides adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

**WHEREAS**, Section 9, Article II of the 1987 Philippine Constitution provides that the State affirms labor as a primary social economic force. It shall protect the right of workers and promote their welfare;

**WHEREAS**, Section 24, Article II of the 1987 Philippine Constitution provides that the State recognizes the vital role of communication and information in nation-building.

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod in session duly assembled to enact:

**SECTION 1. TITLE.** This ordinance shall be known as the ***“Reasonable Opportunities for People’s Employment (ROPE) Ordinance*** of General Santos City.

**SECTION 2. PURPOSE.** This ordinance will give the Generals greater information on job opportunities in General Santos City.

## **SECTION 3. DEFINITION OF TERMS.**

- a) Business establishment- refers to commercial establishment operating/doing business in General Santos City.
- b) PESO- refer to the Public Employment Service Office Gensan.
- c) LGU-GSC- Local Government Unit of General Santos City (LGU-GSC).
- d) ROPE- Reasonable Opportunities for People’s Employment.
- e) CPIO- City Public Information Office.

## **SECTION 4. POLICY.**

- a) Business establishment shall submit to the Public Employment Service Office Gensan job vacancies for posting in designated ROPE bulletin as well as complete information as regards applicants hired/placed in their respective establishment to ensure the availability of accurate information on supply and demand for skills in the labor market.
- b) The PESO Gensan shall initiate the posting of the list of job vacancies in the designated ROPE bulletin and in the PESO Gensan FaceBook page, and copy furnishing the DOLE FO & CPIO for similar posting in the DOLE 12 & LGU-GSC website “free-of-charge” for a period of one (1) month.
- c) The PESO Gensan shall refer “for free” jobseekers suited to the job vacancy as required by the business establishment after complying the basic requirements for employment.

**SECTION 5. SEPARABILITY Clause.** If for any reason, any section or provision of this Ordinance or any part thereof, or the application of such section, provision or portion is declared invalid or unconstitutional, the remainder thereof shall not be affected and shall remain in full force and effect.

**SECTION 6. EFFECTIVITY.** This Ordinance shall take effect immediately.
