WHEREAS, the Barangay Officials who have rendered service for three (3) consecutive terms are hereby given gratuity in recognition of services rendered to the City in addition to what is provided for under the law.

AN ORDINANCE PRESCRIBING GUIDELINES IN THE GRANT OF SERVICE BENEFITS/INCENTIVES TO ALL ELECTED BARANGAY OFFICIALS IN GENERAL SANTOS CITY WHO HAVE RENDERED THREE (3) CONSECUTIVE TERMS OF OFFICE.

Be it ordained by the Sangguniang Panlungsod of General Santos that:

SECTION 1. All elected Barangay Officials who have completed three (3) consecutive terms as Punong Barangay or Barangay Kagawad are hereby bestowed a “Distinguished Public Servant Award.”

Only the Punong Barangay or barangay Kagawad who has not been declared guilty of any administrative or criminal offense by any government agency, quasi-judicial body or court of justice at any time during his/her term of office shall be entitled to the benefits provided under this ordinance;

SECTION 2. The “Distinguished Public Service Award” shall consist of the following:

- a) A Plaque of Appreciation
- b) A cash reward of Thirty Thousand Pesos (Php 30,000.00) for each three (3) termer Punong Barangay and Twenty Thousand Pesos (Php 20,000.00) for each three termer Barangay Kagawad.

The “Distinguished Public Service Award” shall be bestowed by the city Mayor to the recipient at the City Hall Flag Raising Ceremony at the end of his/her term.

Section 3. In cases where the highest ranking Barangay Kagawad shall succeed the position of Punong Barangay by virtue of operation of law under Title two, chapter 2of the Local Government Code of 1991 on Vacancies and Successions, on his third (3rd) term as Barangay Kagawad, the latter shall receive the same cash award as that given to Barangay Kagawad mentioned in this section.

Section 4. The City shall allocate shall allocate funds for the distinguish public service award.

Section 5. The Barangay Council shall submit to the office of the City Mayor, thru the Integrated Barangay Affairs (IBA), the list of qualified Barangay Officials entitled to the benefits provided under this ordinance one (1) month after the assumption of office of the newly elected barangay officials.

Section 6. This Ordinance shall benefit those Barangay Officials who has rendered three (3) consecutive terms in the year 2016 and thereafter.
