The session started with a prayer song followed by the singing of the Philippine National Anthem and the General Santos City Hymn by the General Santos City Government Performing Arts Company—Choir Division. The session was called to order at 9:10 o'clock in the morning with the Honorable City Vice-Mayor Shirlyn L. Bañas-Nograles presiding. After the roll has been called and there being a quorum, the chair thereupon declared the 112th regular session open for business.

F. READING AND ADOPTION OF MINUTES OF THE 111TH REGULAR SESSION:

On separate motions, Councilor Lagare moved for the dispensation of the reading and approval of the minutes of the 111^{th} regular session, duly seconded by Councilors Bagonoc & Tan. There being no correction manifested, said minutes was then ruled adopted.

MINUTES OF THE 111TH REGULAR SESSION - ADOPTED

Before proceeding to the privilege hour, Hon. Bañas-Nograles relinquished the chair to Hon. Lagare.

(Hon. Dominador S. Lagare III - Presiding Officer)

G. PRIVILEGE HOUR:

The first speaker was **Hon. Shirlyn L. Bañas-Nograles**. First, she took issue of the ubiquitous spread of haze in the city. After giving a backgrounder of the said phenomenon, she then discussed the possible effects of such environmental disaster, like industrial production losses, cancelled flights, long-term health damages, accidents and loss of lives. She also discussed some measures undertaken by other affected neighboring countries. On suspended rules, Mr. Allan Punay (CAAP Gensan Manager) and Mr. Edgardo Cueto (Chief Air

Traffic Controller of General Santos Airport) responded to queries by some councilors on the effect of haze to the airport's operation. After some exchange of ideas, Mr. Cueto declared that the weather is improving as of this date, as such no more cancellation of flights is expected. As to the provision of an Instrument Landing System (ILS) to enable planes to land even under extreme weather condition, Hon. Cloma reminded that there was already a resolution passed requesting CAAP to repair the ILS of the airport and that the same would eventually be addressed since the General Santos City Task Force had already requested from the national office for the provision of ILS from the surplus of P135 million. At the outset, Mr. Cueto requested to stop the burning activity at the open dumpsite in Bawing area as complained by airline pilots which was corroborated by some photos taken and presented by Hon. Leyson. Being so, the chair instructed the secretariat to invite the Waste Management Office (WMO) personnel to present the situation of the said dumpsite next session.

Still on suspended rules, the speaker called on Dr. Melly Lastimoso of the City Health Office and Dr. Agripino Dacera of the City Disaster Risk Reduction and Management Office, who further discussed on the haze problem of the city. Dr. Lastimoso negated the news that haze is the cause of death of two persons as reported by media since it is more of an observation. There was no clinical evidence that would directly link or prove that haze was the cause of their death by asthma attack. However, she advised to follow the health advisory from the Department of Health as precautionary measures and further recommended for the implementation of the anti-smoking/smoke belching ordinance of the city, and to practice healthy lifestyle as well. Dr. Dacera also elaborated on the incident of haze in the city as per advisory posted on the Official Gazette of the Republic of the Philippines dated October 26, 2015. He then reported that the situation is beginning to normalize and that fair weather is expected in the coming week. He also assured that their office has been monitoring this situation.

After some exchange of ideas, Hon. Bañas-Nograles thanked the guests for their attendance and giving enlightenment with respect to haze phenomenon in the city. She also emphasized the need to be continuously vigilant for the protection of the environment and encouraged everyone to be proactive rather than reactive.

Secondly, the speaker commended and expressed profound gratitude to the Kiwanis Club of General Santos and LN4 Foundation on their "Kiwanis Hands On Project", which is in collaboration with the city government and other organizations, giving prosthetic arms to 48 recipients in the city. On suspended rules, Dr. Homer Matias, Dynamic Movers President of Kiwanis Club of General Santos City, expounded on the said project/program and gave a brief backgrounder of LN4 Foundation as their partner on the said endeavor. One of the recipients of the said program, Mr. Joel Sunggahib, was presented. He shared his experience and thanked the organization for considering him as one of the recipients of the said program. Further, Dr. Matias made known the new ambassadors of LN4 Foundation in General Santos City.

Lastly, the speaker thanked the presence of their guests and expressed profound gratitude for the benevolence of the said organization. She then concluded that a resolution will be passed under Other Business commending and giving special citation to Kiwanis International and LN4 Foundation in recognition of their benevolence in making General Santos City a yearly recipient of the prosthetic arm program.

Before proceeding to the next speaker, Hon. Lagare relinquished the chair to Hon. Atendido.

(Hon. RICHARD L. ATENDIDO – PRESIDING OFFICER)

The second scheduled speaker was **Hon. Elizabeth B. Bagonoc**. She took issue of the recent threats and challenges brought about by mankind's abuse and irresponsible management of the environment, like climate change, typhoon "Lando" and the prevalent haze in the city, and what can be done about it. She discussed the important areas to focus in order to be resilient to climate-related disasters, namely: Managing upstream watersheds to prevent floods; improving land rights, livelihoods and relocation programs to informal settlers.

At this juncture, the speaker congratulated the CDRRMC and the entire Local Government of General Santos City headed by Mayor Ronnel C. Rivera, for having been conferred the accolade as the Best City Disaster Risk Reduction and Management Council for the Highly Urbanized Category; and Dr. Agripino Dacera of the CDRRMO for winning second place for Best Government Emergency Response Management (Basic and Rescue) for Gensan Rescue 727 for the 2015 Regional Gawad KALASAG Award. This award is given to LGUs based on their disaster preparedness and capability to respond to the needs of its constituency during emergencies or in times of calamity.

Further, she encouraged everyone to be a part in protecting the environment. She also informed that various business groups in the country have joined the mounting call on the world leaders to come up with a binding statement agreement that will address the threat of climate change especially in vulnerable countries like the Philippines. She then emphasized that participation of every stakeholder to sufficiently address climate change is very essential. Relative thereto, she tackled a very important environmental issue – the degradation

of urban forest and the unauthorized and indiscriminate cutting of approximately forty (40) trees particularly along Makar Road, this city. After a short slide presentation, the speaker under suspended rules, gave way to Ms. Tess Garay of CENRO. At his juncture, Hon. Atendido relinquished back the chair to Hon. Lagare.

(Hon. Dominador S. Lagare III – Presiding Officer)

Ms. Garay delivered her report based on the result of the investigation they have conducted on the alleged cutting of assorted tree species along Makar Road, Barangay Labangal, this city, due to road-widening project. Barangay Kagawad Gepte of Labangal who apprehended the alleged violator, also narrated and shared his sentiments on the said incident. After some exchange of ideas, Engr. Provido of the City Engineers Office suggested to request the DPWH to submit to the city the Development Plan of the National Highway to be used as guide where to plant trees properly so that same incident will not happen again. Hon. Melliza recommended that Kagawad Gepte could continue with the filing of the case in court even if the apprehended violator was released. After further discussion, the chair resolved to invite the following, in the next session to give enlightenment on this issue, to name: Engr. Ronald Quitalig, Project Engineer of DPWH-GSC; Mr. Cader Lumna, Forester I/Chief, DENR-CENRO Region XII, Buayan; Mr. Connieboy Andajao, DENR-CENRO, Buayan; Mrs. Florita Malayon; Desk Officer SPO2 Juanito D. Aboro and PO2 Rafanan, all of Police Station 02, Makar; Engr. Pio Lumongsod of DPWH; and Mr. Val Lastimoso of CENRO. Sending of representatives is discouraged. Hon. Bagonoc wrapped up her topic with the hope that the right key persons will be present in the next session to give enlightenment on the issues at hand. She then thanked the guests for their presence.

This time, the chair declared a recess for the members of the Council to have photo-ops with Dr. Dacera of CDRRMO for the ceremonial turning over of the plaque received by the city.

Hon. Bagonoc took issue of the petition of the members and friends of The Pioneers-Descendants of General Santos City re: DECLARING THE FAÇADE OF STS. PETER AND PAUL PARISH CHURCH, LAGAO, GENERAL SANTOS CITY AS CULTURAL HERITAGE. The chair informed that said matter will be scheduled for a consultative hearing by Hon. Llido-Pestaño as the chairperson of the Committee on Tourism and that all stakeholders will be invited including the Bishop, the Parish Priest, all SP members and if possible, a representative from the NHI.

The chair raised another concern regarding ordinance banning the selling of cigarettes in packs. She said that all councilors were given a copy of said letter-inquiry. She then manifested that said concern was already forwarded to the Committee on Games and Amusements and will be discussed further in the next session.
