Amendments:

1. Sec 1 shall read as “all elected officials who have served three (3) consecutive terms as punong barangay or barangay kagawad beginning 2016 are hereby granted a Distinguished Public Servant Award.”
2. 2nd paragraph of Sec 1 is read as “Only the punong barangay or barangay kagawad who has not been declared guilty by final judgment in any administrative or criminal case in relation to his/her office wherein the judgment includes for the forfeiture of all benefits or his/her position or by any government agency, quasi-judicial body or court of justice at any time during his/her term of office shall be entitled to the benefits provided under this ordinance.”
3. Sec 2 instead of “Public Service Award” shall read as “The Distinguished Public Servant Award” shall consist of the following:
 - a) Plaque of Appreciation
 - b) A cash reward of One Hundred Thousand Pesos (P100,000.00) for each three consecutive term punong barangay and Fifty Thousand Pesos (P50,000.00) for each three term barangay kagawad.
 - c) The Distinguished Public Servant Award shall be handed by the city mayor to the recipient at the City Hall flag raising ceremony at the end of his/her term.
 - d) Sec 3 shall read as: In cases where the highest ranking barangay kagawad shall succeed the position of the punong barangay by virtue of operation of law under Title Two, Chapter 2 of the Local Government Code of 1991 on Vacancies and Succession, on his/her third term as barangay kagawad, the latter shall receive the same plaque of appreciation or and a cash award for the position he was last elected.
 - e) Sec 5 shall become Sec 4 and shall read as: “In the event where an elected official is elected for five (5) consecutive terms and on his 5th term he is deemed a graduate, the said barangay official shall likewise receive the incentive under this ordinance upon completion of the 5th term.
 - f) Sec 6 shall read as: “In the event that during the 3rd term of the elected barangay official he or she dies, he shall still receive posthumously the award to be received by his or her heirs.
 - g) The original Sec 4 shall now become Sec 7 to read as: The City Government of General Santos shall allocate funds for the Distinguished Public Servant Award.”
 - h) The original Sec 6 will become Sec 8.
