The session started with a prayer song followed by the singing of the Philippine National Anthem and the General Santos City Hymn by the General Santos City Government Performing Arts Company–Choir Division. The session was called to order at 9:14 o'clock in the morning with the Honorable City Vice-Mayor Shirlyn L. Bañas-Nogralles presiding. After the roll has been called and there being a quorum, the chair thereupon declared the 114th regular session open for business.

F. READING AND ADOPTION OF MINUTES OF THE 113TH REGULAR SESSION:

On separate motions, Councilor Lagare moved for the dispensation of the reading and approval of the minutes of the 113th regular session, duly seconded by Councilors Atendido, Nuñez & Tan. There being no correction manifested, said minutes was then ruled adopted.

MINUTES OF THE 113TH REGULAR SESSION – ADOPTED

At this juncture, Hon. Bagonoc sought reconsideration for a correction on the minutes of the 111th Regular Session dated October 20, 2015. After the granting of her reconsideration, she then moved that the amount of FIVE MILLION PESOS (₱5,000,000.00) be corrected to **TEN MILLION PESOS (₱10,000,000.00)** as reflected on Amendment No. 1 of Item No. 1 of Unfinished Business, page 2. Having been seconded and there being no objection manifested, said correction was ruled adopted.

MINUTES OF THE 111TH REGULAR SESSION – AMENDED

G. PRIVILEGE HOUR:

Hon. Richard L. Atendido availed of the privilege hour after having been reconsidered. He took issue of the vacancy of the Liga ng mga Barangay representative in the City Council in view of the resignation of ABC President, Hon. Rogelio D. Pacquiao. After discussing some pertinent laws/guidelines, he contended that Barangay Captain Veneracion as the vice president of the Liga ng mga Barangay, has completed all the needed

requirements for him to represent the Liga, as such he could assume the post and sit as the representative of the ABC. After some discussion, a RECESS was declared at 9:35 A.M.

The session RESUMED at 10:06 A.M. Discussion ensued and after a lengthy exchange of ideas and considering that there are still matters/concerns that need to be clarified, it was resolved to wait for the lapse of fifteen (15) days in which case the resignation of Hon. Pacquiao is considered effective. It was also suggested that Barangay Captain Veneracion will secure two more additional signatories on the confirmation of the National Liga Board to avoid possible legal questions that might stain the legitimacy of his assumption as ex-officio member of the Sangguniang Panlungsod. Further, the chair advised Barangay Captain Veneracion to coordinate with the Office of the Vice Mayor as the administrative head of the Office of the Sangguniang Panlungsod relative to the issue at hand, for proper protocol. The chair also manifested that the City Council would always welcome Barangay Captain Veneracion should all the requirements of the law be complied with.

Before proceeding to the next speaker, Hon. Bañas-Nogralles relinquished the chair to Hon. Melliza.

Hon. Dominador S. Lagare III as the second speaker after his reconsideration was granted, discussed the non-completion of the construction of Calumpang Community Hospital inside the Antonio C. Acharon Sports Complex which has been the subject of discussion of this Council in the past few weeks. For the enlightenment of his colleagues, he took upon himself the cudgel to study further the subject matter and present its result to the body. He presented the 3-storey design of the building and a backgrounder as to what really happened to this project based on the documents he gathered and on his interviews with department heads concerned. He also read and discussed the Audit Observation Memorandum (AOM) issued by Commission on Audit (COA) dated January 5, 2015. He then emphasized the need to address or clear the concerns cited in the AOM before the project can proceed to its phase two. He then concluded that a team be created to study further on how to proceed with the project whether to make it a hospital or make it into other facility, in order to make the said project usable and beneficial to the constituents of the city. On the period of discussion, there were exchange of ideas. Meanwhile, Hon. Melliza relinquished back the chair to Hon. Bañas-Nogralles.

After a lengthy discussion, all manifestations were duly noted by the chair. On suspended rules, Barangay Secretary Juris Cerbo of San Jose conveyed that it would be beneficial on their end if said health facility be materialized. He also supported the idea of forming a team to address the subject matter under consideration and thereafter suggested to take into consideration the recommendations how to satisfy the deficiencies and how to address the issues raised in the AOM of COA. Thereafter, house rules was resumed and they proceeded to the next item.
