A prayer song rendered by the General Santos City Performing Arts Choir Division followed by the community singing of the Philippine National Anthem and the General Santos City Hymn heralded the opening of the session. The Honorable Vice Mayor Shirlyn Bañas-Nogralas acknowledged the presence of some barangay captains and kagawads, purok officials, former Councilor Whittmer, the media around and particularly the junior city officials who were seated at the side of their respective councilor counterparts and also that of the junior city mayor and the junior vice mayor and thereafter called the session to order.

Before the roll call the Vice Mayor read the Temporary Restraining Order issued by the Regional Trial Court Branch 35 as regards the Civil Case No. 8664 filed by Edgar Acharon, Honorio Loricar, Jr., Armando N. Diamante, et al *versus* The National Executive Board of the *Liga ng Mga Barangay sa Pilipinas*, represented by Edmund Abesamis, John Patrick Agustin, et al which directs this Sangguniang Panlungsod not to recognize the assumption of Brgy. Captain Alvin Veneracion as president of the *Liga ng mga Punong Barangay of Gen. Santos City*. Thereafter, Councilor Leyson IV asked what damage would it do to the public the assumption of Brgy. Captain Veneracion in which Councilor Melliza cautioned the honourable members not to discuss the merit of the case since the order was from the court.

The chair at this juncture acknowledged the presence of Brgy. Captains Veneracion and Casabuena of Dadiangas South and City Heights, respectively. The roll call followed and the result of which was seven members present including the presiding officer in which the chair ruled there was a quorum. Questioning the ruling for a quorum, it was explained by Councilor Melliza that the ABC president is still included in the determination of a quorum since his

resignation was not yet acted upon. After some more discussion the chair ruled to proceed to the next item.

#### **K. QUESTION AND ANSWER HOUR:**

As regards the query of Councilor Nuñez which was accordingly an offshoot to the exit conference conducted by DILG and other agencies where it was learned that City of General Santos was allocated three pipeline projects under Bottoms Up Budgeting (BUB) Fund of the DILG namely, nine (9) Day Care Centers, Completion of Bahay Pag-asa and the improvement of the Office of the Senior Citizens (OSCA) which totalled to P6.5 Million and which also requires a Local City Counterpart of P15.2 Million, after deliberations the chair advised the CSWDO to once again write the Local Finance Board for the inclusion of the foregoing to the next supplemental budget and the Committee on Finance was directed to assist.

The next concern discussed was the alarming or scandalizing case of Sukarap, a group of juvenile delinquents and a burgeoning serious social problem in the city. They were known before as "Batang Ton-og" and they levelled up to *Sukarap* as they engaged into some kind of illicit and highly immoral activities. Their moral decadence as reported was outrageously contemptible. The chair ruled to refer the same to the Committee of Social Services chaired by Councilor Lido-Pestaño and for a possibility of creating a task force to that effect. Relative issues and concerns will be discussed during the respective consultative hearing.

The presence of SOCOTECO II was sought next session as regards its proposed lighting project in Tambler but reportedly opposed by IP claimants. Likewise, the presence of Water District was likewise required to explain its delayed project (deep excavation) along Aparente Avenue that causes heavy traffic.

Concerning the TRO filed against Brgy. Captain Veneracion, the chair said they will discuss the same during their lunch break. Every councillor will be furnished a copy of the attachments/documents.

Lastly, Ms. Dime reminded everybody to pay the monthly dues for the coming Christmas Party on December 8, 2015.

#### **L. ANNOUNCEMENT**

The chair was happy to announce that this Sanggunian Panlungsod had won the Regional Award (for Highly Urbanized City) in the recent Local Legislative Award Evaluation and she thanked everyone, the councillors and staff for their able support and cooperation. She again urged the body for the same support and cooperation as this sanggunian is once more vying for the national award and the deadline for submission of this council's final report will be on November 19, 2015.
