Responding to the query of the chair, Barangay Captain Jose Edmar Yumang said that this measure is out of the suggestion of the City Health Office to give emphasis the adoption of a city ordinance in which City Councilor Nuñez also viewed that it is like a national law that is adopted by the city. And she said adopting a city ordinance would give emphasis to a very important program in the barangay.

Ensuing further deliberations, the committee believed that the passage of the aforesaid measure may not be very necessary because it already encompasses the entire General Santos City. But because of the desire of Barangay San Isidro to really address its malnutrition problem; hence, this item was ruled approved on committee level and to be calendared for second reading on November 17, 2015 with City Councilors Ramon R. Melliza, Franklin M. Gacal, Jr. and Rosalita T. Nuñez, MNSA/PhD as the principal sponsors.
