The hearing was presided by its Chairperson, City Councilor Honorable Franklin M. Gacal, Jr. to discuss this agendum, ***SPPO NO. 2015-1116: AN ORDINANCE IMPOSING COST OF SALE ON THE PUBLIC AUCTION OF DELINQUENT REAL PROPERTIES IN GENERAL SANTOS CITY.***

The chair informed the City Treasurer, Mr. Rodilon C. Lacap that the media met him just this afternoon because the latter proceeded with the auction sale without the cost of sale. On the other hand, Mr. Lacap said that there are about 800 real property units which are now on auction sale posted at the city hall lobby. The rate is 10% of the amount published including the delinquent tax and accrued penalties.

The Chair commented that although the city passed an amnesty ordinance last year to give the people a chance to pay their real property tax but still some failed to pay it. After some advices and announcements, the chair ruled this item approved in the committee level and to be calendared for second reading on November 17, 2015 regular session. Further, he manifested the attendance of Honorable Arturo Cloma and Honorable Melliza who were at the same time having a committee hearing in the other room.
