COUNCILORS PRESENT: Hon. Arturo C. Cloma (Chairperson), Hon. Elizabeth B. Bagonoc.

The committee hearing was called to order by its chairperson, City Councilor Arturo C. Cloma with a manifestation that City Councilors Elizabeth B. Bagonoc and Brix T. Tan would be coming. He then acknowledged the presence of the attendees before the following agenda were discussed:

City Councilor Cloma apprised the body that he together with the representatives of the DPWH and De Lagare Multi-Investment Corporation, and the barangay officials had visited the area. Accordingly, it was found out that there was a departure of the road from that of the actual one the reason why the landowner cut it which measurement was not the same with that appearing in the approved plan.

After some manifestations, Mr. Sarayno, representative of the De Lagare Multi-Investment, Incorporated also disclosed that as requested by the barangay, the present road should remain. But since it has no Deed of Donation yet, the landowner wanted to amend the approved subdivision plan in which Engr. Toribio stressed the only problem was on the measurement of the existing road which was only 10 meters.

Mr. Andrade of City Engineer's Office thereupon explained that the problem was on the cut portion of the road which measurement did not jibe with that of its supposed location that's why the approved subdivision plan has to be amended, but he said an amendment of a road needs a court approval in which Engr. Urmenita also viewed that it's up to the landowner to amend the subdivision plan in accordance with the DPWH requirement of a twenty (20)- meter road strip. With this, Mr. Sarayno relayed that Dra. Lagare had already agreed to the said measurement just to resolve the problem.

Engr. Urmenita finally said that their office would support the aforesaid request provided the twenty (20)- meter road strip requirement is complied. Anyway, she said the landowner had already signified that the road within their property will remain and the amendment of which will be in conformity with what is indicated in the subdivision plan.

The chair after saying that this be endorsed to the DPWH ruled the same approved on committee level and to be calendared for second reading on November 24, 2015.

There being no more matter to be discussed, the chair declared the committee hearing adjourned at 3:19 in the afternoon.
