WHEREAS, the Memorandum of Agreement (MOA) to be entered into by and between the City Government of General Santos and Department of Education-General Santos City (DepEd-GSC), represented by the Schools Division Superintendent, defines the terms and conditions for the transfer of funds from the LGU-GSC to the different schools through DepEd-GSC for the implementation of various programs and projects, pursuant to COA Circular No. 2012-001, dated June 14, 2012;

WHEREAS, this joint effort of the abovementioned government agencies is necessary in order to perfect the allocation of funds from the LGU-GSC to DepEd-GSC for them to implement programs, projects and pertinent activities that will redound to the betterment of the entire city constituency;

WHEREAS, this *Sanggunian* finds the MOA in order pursuant to the provision of Section 455, Paragraph (b) (1) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the City Mayor to represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod concerned pursuant to law or ordinance.

NOW, THEREFORE, on motion of City Councilor Franklin M. Gacal, Jr., duly seconded by City Councilors \_\_\_\_\_, be it-

RESOLVED, as it is hereby resolved, to authorize the City Mayor, Honorable Ronnel C.
