WHEREAS, Section 3, Rule 1 of the said IRR- states that "No disposition, administration or management in whatever form of contracts/grants involving any land of the public domain within the city shall be granted without the concurrence of the City Government of General Santos, as embodied both in the recommendation of the City Mayor and in a resolution of the *Sangguniang Panlungsod* voted affirmatively by at least two-thirds (2/3) of all the members thereof;

WHEREAS, Mr. Ronald M. Vicente has sought for the concurrence of Free Patent Application of a certain parcel of land situated in Barangay Calumpang, General Santos City, which application has been screened and evaluated by the Department of Environment and Natural Resources for the issuance of Free Patent Application;

WHEREAS, the City Planning and Development Office certifies the lot is classified as "Residential Zone" per Zoning Ordinance No. 10, Series of 2001 which was duly concurred by HLURB per Resolution No. R-742, Series of 2003;
